## Children's Rights **Parents Must Know**

## **CENEP** (Child Education and **Nutrition Enhancement Program**)

On January 26, 2018, parents of children at CENEP Cainta listened to Atty. Rose Buendia discuss basic rights of children contained in the 1989 Convention on the Rights of the Child that defines a child as "...any human being below the age of eighteen years."

Atty. Buendia emphasized the responsibility of parents to give their children the necessary care and protection, "...As minors by law, children do not have autonomy or the right to make decisions on their own for themselves in any known jurisdiction of the world. Instead, their adult caregivers, including parents, social workers,

teachers, youth workers, and others, are vested with that authority, depending on the circumstances."

Atty. Buendia discussed examples of abuses commonly committed against children and the corresponding penalties. Parents' questions were duly answered and they were advised that (CENEP...continued on page 2)

(CENEP...continued from page 1) many legal concerns have clear-cut solutions. Unnecessary delay in attending to simple cases may only lead to more complicated situations.

Every parent must know their duties and obligations to their children and it is best for them to be aware of and armed with knowledge of relevant law.
